MUNICIPAL BOARDS OF FINANCE

QUESTIONS

Which municipalities have a board of finance and what is their form of government? How do municipalities with boards of finance elect members and fill vacancies?

SUMMARY

Of Connecticut's 169 municipalities, 120 (71%) have a board of finance. These municipalities vary according to their form of government, but generally follow the same distribution as Connecticut municipalities as a whole: 95 (80%) have a selectmen-town meeting, six (5%) have a representative town meeting, 11 (9%) have a mayor-council, and eight (7%) have a manager-council form of government.

The methods for selecting and filling vacancies on boards of finance depend on whether a town operates under the state statutes (i.e., statutory town) or under a charter (i.e., charter town). For statutory towns, state law establishes the selection and vacancy-filling methods. For charter towns, the charter establishes the methods. Regardless of whether a municipality operates under the statutes or a charter, it must comply with state law's minority representation requirements, which prohibit members from the same political party from comprising more than a specified percentage (generally two-thirds) of a board's membership.

MUNICIPALITIES WITH BOARDS OF FINANCE

Table 1 lists the municipalities with boards of finance according to their form of government and indicates whether each municipality operates under a charter or the statutes. Of the 120 municipalities, 73 are charter towns and 47 are statutory towns.

BOARD OF FINANCE SELECTION AND VACANCY FILLING METHODS

Statutory v. Charter Towns

The methods for selecting board of finance members and filling vacancies depend on whether a town operates under the statutes or a charter. For statutory towns, state law requires the board to consist of six electors who serve six-year, staggered terms; two members are elected at each regular municipal election ($CGS \S 9-202$). Statutory towns may, by ordinance, opt to elect or appoint up to three alternate members, subject to minority representation requirements ($CGS \S 7-340a$). In the case of a vacancy, the remaining board members appoint a temporary replacement at a special meeting called for that purpose. The appointee serves until the next municipal election, at which point a successor is elected to fill the remaining portion of the term ($CGS \S 7-343$).

For charter towns, the methods for selecting board members and filling vacancies are determined by the charter. We selected and reviewed a sample of 35 (out of 73) Connecticut municipalities that have a board of finance and operate under a charter (see Table 3). Two of the 35 municipalities (Branford and Bristol) have an appointed board of finance. The rest elect their board members at regular municipal elections, typically for staggered terms.

The boards in our sample have between six and nine voting members, and four years is the most common term length. The boards fill vacancies by appointment initially, typically by either the board itself or by the board of selectmen or town council. In many municipalities, the appointee serves only until a special election or the next regular municipal election, at which time a successor is elected to fill the remaining portion of the term.

Minority Representation

Regardless of whether a municipality operates under the statutes or a charter, it must comply with state law's minority representation requirements.

The law requires minority political party representation on certain governmental bodies of the state, its towns, and other political subdivisions. No more than a specified number of members (generally two-thirds of the total) enrolled in the same political party can serve on a particular body, as shown in Table 2. Municipalities may enact a greater degree of minority representation than required by the state through the adoption of a charter provision that sets a lower maximum number from the same party (CGS \S 9-167a).

Most of the 35 municipal charters we reviewed establish minority representation requirements that conform to those established in state law. Only three municipalities in our sample (Branford, Burlington, and Columbia) impose minority representation requirements for the board of finance that are stricter than those imposed by state law.
